



HONORARY DEGREE RECIPIENTS

Call for Nominations

Members of the St. Thomas University community are invited to submit nominations, in writing, **by 12:00 noon on Wednesday, November 17, 2021** for honorary degrees from St. Thomas. All nominations must remain **CONFIDENTIAL** at all stages of the process; hence NOMINEES SHOULD NOT BE NOTIFIED of the nomination, as the University cannot possibly recognize all the worthy candidates.

Criteria for Nomination

While flexibility is the norm, persons submitting nominations ought to be guided by two questions:

- a) What distinction has the person achieved as an academic, artist, educator, administrator, public servant, or scientist, or in any other recognized way?
- b) What significant contribution has the person made, directly or indirectly, to the life of the university, the local community, the province, the region, Canada, or the world?

Guidelines for Selecting Candidates

No strict categories of recipients are defined, but the following guidelines are suggested:

- a) That, normally, recommendations shall include at least one distinguished scholar for each ceremony;
- b) That the nomination and recognition of people not already honored by other institutions, or in a public manner, be encouraged;
- c) That the University not normally bestow honorary degrees on currently serving members of the Board of Governors, faculty, staff, or currently-sitting politicians (e.g., MLAs, MPs, mayors, etc.) who serve the local jurisdiction; and
- d) That nominations remain before the Nomination Committee for three years.

Using the attached form, provide a nomination to the Committee that reflects your confidence in the nominee's worthiness to receive an Honorary Degree from St. Thomas University. Providing only material printed from websites, URLs, and/or printed copies or links to curriculum vitae or resumes will not be considered sufficient material for adjudication of your nomination.

NOTE ON PROCESS

All nominations are reviewed by the Joint Board-Senate Committee for Honorary Degrees which makes recommendations to the Board of Governors. All nominations must remain **CONFIDENTIAL** at all stages of the process; hence NOMINEES SHOULD NOT BE NOTIFIED of the nomination, as the University cannot possibly recognize all the worthy candidates. Nominators must also respect this process, which means that nominators must not inform the nominee that his/her name has been submitted. While the secretary to the Committee will acknowledge receipt of all nominations, nominators will not be informed of the outcome of their nominations.

Please note that this nomination will be under active consideration for three (3) years from the date of submission, or until the nominee is selected, whichever occurs first.
